April 16, 2018	Voter Registration open – Forms may be picked up at the Zuni Tribal Census Office or the Election Board Office; bring pertinent documents.
April 23, 2018	Notice of Tribal Election
May 07, 2018	Nomination packets available – Election Board Office located in the Zuni Tribal Bldg.
June 29, 2018	Deadline to submit Nomination packets for office of Governor/Lt. Governor and Tribal Council.
July 05, 2018	Post “Notice of Primary Election” and List of All Nominees of more than two (2) teams for the Governor and Lt. Governor, to be held on August 12, 2018, pursuant to the Election Code.
July 05, 2018	Persons can request absentee ballot via phone, e-mail at Election.Board@ashiwi.org , or at the Election Office, or through written request at PO Box 339.
July 27, 2018	Deadline for Voter Registration for Primary Election
July 27, 2018	Deadline for Request of Absentee Ballot for Primary Election
August 12, 2018	ZUNI TRIBAL PRIMARY ELECTION – if necessary.
August 13, 2018	Posting of official “Nominees” for the Zuni Tribal General Election
August 13, 2018	Voter Registration re-opens.
