We, the undersigned members of the Zuni Election Board, and appointed Poll Workers certify the Zuni Tribal Primary Election to be completed this 10<sup>th</sup> day of August, 2010 at Zuni, New Mexico. Of the 3350 registered voters, 859 ballots were cast at the polling place with 36 absentee ballots and 2 hand tally absentee ballots received for a total of 897 ballots.
